- 7. **Tournament:** Will be receiving list for the State Championship and will order awards. Shoot to be held at Granby the weekend of March 24th and 25th. The indoor Sectional to be held at Lunenburg on April 13-15. Please get your applications in for these shoots as early as possible.
- 8. **NFAA Directors Report/NFAA Costitution/By-Changes:** Paul Lewkowicz gave a hand out with information on the NFAA Annual Meeting for review and touched on some of the key items that will affect the MFAA.

*The NFAA has proposed splitting up the competition for the Indoor Nationals between a 300 and 450 round to mix it up and reducinig shoot-offs. No vote on this yet, will pole at Indoor Nationals.

- *Outdoor nationals shooot dates: 2012 on July 25-29 at Mechanicsburg PA, 2013 7-24-28 at Darrington: 2014 7-21-25 at Yankton.
- *Maximum arrow speed was changed to remove the 3% rule and will now be 309 Ft per Second.
- *Guest class was discussed extensively and the final ruling 36 for 12 agains was that guest participants will be participants not competitors, they will not be given award or scores posted on score board. You must be a member for recognition.
- *Long bow division has been added and must be shot with wood arrows
- *x ring for bonus scoring was defeated, general consensus was that it may reduce participation.
- *Pro recurve devision was added in exchange will phase out Pro FreeStyle Limited by end of 2012
- *Pro Dress code implemented and will be posted
- *Archery Magazine opt out of mailing paper copies in favor of email notification that the new issue is posted on the NFAA website was recommended and Adopted.

Old Business:

- 1. <u>Waivers:</u> Paul has requested a report from the secretar as to the number of MFAA members that have a waiver on file as of today. Clubs are reminded that in the event that someone is injured durig a shoot, the NFAA insurance (and perhaps other insurance) will NOT cover the Clubs liability. In that cas, the Club will be liable to pay any damages. This liablity usually extneds to the Officers of the Club and to Officers fo the MFAA.
- 2. <u>Rnage Inspections:</u> Club reps are reminded to call or email Paul to arrange inspections. Next ones due are Pequoig(Outdoor by 5/31) and Lunenburg (Outdoor by 6/30).

New Business:

- 1. Duke willard, one of our stonges and longest supports, wsa recently taken vey ill. Paul has asked the Membership to make a gift of flowers to Duke to aid his recovery.
- 2. Guest Class- As a result of the vote take at the NFAA Annual Meeting (please see note above) MA is currently in conflicked with this newly revised NFAA By-laws. (article V, section 6) Section 6.B will be stuck from the MFAA by Laws effective 6/1/2012. Guests will not be ranked at all.
- 3. State Indoor and Outdoor Championships-Members and Clubs are reminded that per our By Laws the state indoor and outdoor championship hosts are selected by alphabetical rotation at the October Shoot pick Meeting. However, any Club/Shop not present at more than 50% of our regular meetings or not present at the October Pick Meeting is ineligible and loses its turn.
- 4. NE Section indoor,Outdoor and Championship shoots require a bid from the Club or Shop tht wants to host. Bids are due at the spring NESFAA Meeting for the next calendar year(e.g. this Spring we will collect bids and award the 2013 Sectionals/NE Shoot) The procedure is

- explained in the NESFAA By Laws Aticle III and IV. Any Club or Shop that is interested in hosting any of these tournaments should review these documents.
- 5. Boy Scouts of America, Mohegan Council's "TREASURE VALLEY 2012" Scout Show- We have been invited to participate, either by hosting a booth or other display or sponsoring/manning an archery range. The show will be held October 13, 2012 in Rutland.

Good of the Association: Programs like JOAD are growing and suggestion made to get a list of clubs done for referrence to people who are looking where they can go to shoot. A club shoot off was suggested (like all good suggestions, someone needs to step up to organize and take the lead and follow throught to make sure it gets done) any help to keep things going is appriciated.
